



# UPS® Peak Surcharges

## UPS® Peak Surcharges

One or more Peak Surcharges will apply to packages shipped during a Peak Period, based on service level and package characteristics. Peak Surcharges apply in addition to all other applicable Charges.

Peak Surcharges described below apply only to shipments subject to Daily Rates, Alaska and Hawaii Rates (not including Retail Rates), and UPS Hundredweight Service Rates.

## United States Domestic Peak Surcharges

Domestic packages shipped during a Peak Period will be subject to one or more Peak Surcharges, as applicable, as follows:

### A. Peak Surcharge - Applied to Residential Packages

- A Peak Surcharge will apply to each package addressed or delivered to a location that is a home, including a business operating out of a home. The Peak Surcharge will apply in the amounts set forth in the charts below to the indicated service levels and during the specified Peak Periods:

1. Residential packages with origin and destination within the 48 contiguous states, and packages with Alaska or Hawaii origin:

2. Residential packages shipped from an origin within the 48 contiguous states to a destination within Alaska, Hawaii, or Puerto Rico:

#### B. Peak Surcharge - Applied to Large Packages

- A Peak Surcharge will apply to Packages with length plus girth  $[(2 \times \text{width}) + (2 \times \text{height})]$  combined over 130 inches. In addition, during the Peak Period(s) in 2018 listed below, a Peak Surcharge will apply to Domestic packages with a length exceeding 96 inches. The Peak Surcharge will apply to all Service Levels and all Domestic destinations in the amounts set forth in the chart below during the specified Peak Periods:

#### C. Peak Surcharge - Applied to Over Maximum Limits Packages

- A Peak Surcharge will apply to packages with an actual weight of more than 150 pounds, or that exceed 108 inches in length, or that exceed a total of 165 inches in length plus girth  $[(2 \times \text{width}) + (2 \times \text{height})]$  combined, as measured to determine their billable weight. The Peak Surcharge will apply to all Service Levels and all Domestic destinations in the amounts set forth in the chart below during the specified Peak Periods:

D. Peak Surcharge – Applied to Additional Handling Packages

- A Peak Surcharge will apply to packages that require special handling, including, but not limited to:
  - o Any article that is not fully encased in a corrugated cardboard shipping container, including but not limited to any article encased in an outside shipping container made of metal, wood, hard plastic, soft plastic (e.g., plastic bag), or expanded polystyrene foam (e.g., Styrofoam).
  - o Any cylindrical-like item, such as a barrel, drum, pail, or tire that is not fully encased in a corrugated cardboard shipping container.
  - o Any package with the longest side exceeding 48 inches or its second-longest side exceeding 30 inches.
  - o Any package with an actual weight of more than 70 pounds.
  - o Each package in a shipment where the average weight per package is greater than 70 pounds and the weight for each package is not specified on the source document or the UPS automated shipping system used.
- The Peak Surcharge will apply to all Service Levels and all Domestic destinations in the amounts set forth in the chart below during the specified Peak Periods:

## United States Import Peak Surcharges\*

### A. Peak Surcharge – Applied to shipments from China or Hong Kong

- A Peak Surcharge will apply to any shipment originating from China or Hong Kong for the Service Levels and during the Peak Periods set forth below. The Peak Surcharge will be applied as a rate per pound based upon the billable weight of the shipment.
